CURRENT LCP PROCESS UPDATE

- Currently an Aggregator has been appointed and is investigating possible customers to be added to the LCP at different feeder levels. Power star to provide an update at the meeting.
- Miles has begun internal processes with Eskom load shedding committee and probability of Blackheath being removed from the Load-shedding to be exempted from load shedding and reducing demand as per various stages:
- Stage 1 : reduce load by 70 amps
- Stage 2 : reduce load 140amps
- Stage 3 : reduce load 210 amps
- Stage 4 : reduce load 280 amps
- Customer service team will monitor performance in terms of collective performance at substation level.

TRUCK STOP ENGAGEMENT

- Once buy-in has been received from survey respondents has the identified erf in Blackheath and a report will be presented to council to ensure that the listed erf can be reserved for truck holding areas by end of November.

- Electron road reinstatements have been completed and lights have installed.
- Wimbledon investigation is under way
- Helene road is next to be implemented. Funds have been allocated and energy team is currently awaiting supplies
- Nicole Avenue currently has a challenge relating to the water services which does hinder the installation progress
