




BCID Organisational Profile

SECURITY


• We have introduced the Rent-a-Cop service within the Blackheath Industrial Area since 2016. The BCID is often approached by business owners to enforce the law and deal with matters relating to City By-Law enforcement.

 We may now deal directly with City By-Law infringements.
 Illegal dumping, stationary vehicle offences and various other offences may be dealt with directly by the LEO. We have two fully equipped Officers and a patrol vehicle stationed in Blackheath from Monday to Friday between 9am and 4pm.















BCID AGM 2024 BY CATEGORIES

CCTV & LPR CAMERAS

• The Blackheath CCTV Network consists of both overview and license plate recognition CCTV cameras and has been used to our credit in various crime initiatives and in the solving of several serious local crimes.

• It is the backbone of the Public Safety Profile and assists in proactive steps to combat crime.

• The Network, after the latest system upgrades and additional installations now consists of 68 cameras in total.

SERVICED INFRASTRUCTURE

- Assist the Roads Department with prioritisation of repairs and rehabilitation / general maintenance of infrastructure.
- Lobby for installation of pedestrian walkways throughout the area.
- Ensure constant maintenance to storm water canals and other water and wastewater infrastructure throughout the area.
- Address Public lighting concerns and related repairs and maintenance of infrastructure and deal with illegal connections.
- Apply to various City budgets for funding for the necessary area infrastructural upgrades and the required operational projects.
- Create awareness of road conditions and safety.
- Constant reminders on condition of roads.
- Ensure that regular maintenance is carried out.

GREENING PROJECTS

- The City of Cape Town Parks division provides trees to the Blackheath area.
- Due to bark stripping of the Fever Trees, which causes the trees to die, we replaced more of the dead Fever trees with indigenous, water wise trees such as the Ceratonia Siliqua, Ficus Natalensis and Ficus Rubiginosa.
- Irrigation is done weekly in Summer by means of water extracted from local boreholes and donated by local firms.
